#### Invitation to the 2020 Annual General Meeting of Cochlear Limited

Dear Shareholder

I am pleased to invite you to Cochlear's 2020 Annual General Meeting (AGM) which will be held as a virtual meeting on Tuesday 20 October 2020 at 10.00 am (AEDT).

Cochlear has been closely monitoring the COVID-19 situation. In the interests of the health and safety of our shareholders, and having regard to social distancing requirements, the Cochlear Board has decided to hold our 2020 AGM as a virtual meeting. Shareholders will not be able to physically attend the AGM but will instead be able to watch and participate in the AGM online. This approach is in line with temporary modifications to the law and current regulatory guidance.

We acknowledge that virtual meetings are unprecedented and that this might cause disappointment for some shareholders; however, we will do our best to ensure an orderly and effective meeting.

You will be able to use your computer or mobile device through an online platform that will allow you to submit questions to the Chair and vote on resolutions. Further information on how to participate in the AGM online is set out in the Notice of Annual General Meeting and on our Cochlear website at <a href="https://www.cochlear.com/intl/about/investor/annual-general-meeting">https://www.cochlear.com/intl/about/investor/annual-general-meeting</a>.

The formal business to be dealt with at the AGM is set out in the Notice of Annual General Meeting, which also includes the explanatory notes and the Board's voting recommendations.

We invite shareholders to submit questions and comments in advance of the meeting on the enclosed Questions from Shareholders form. If you will not be able to participate in the AGM online, you are encouraged to vote directly or appoint someone to participate and vote on your behalf as your proxy. Instructions on how to vote directly or appoint a proxy are set out in the enclosed Proxy/Voting Form.

Direct votes or Proxy/Voting Forms must be received by 10.00 am (AEDT) on Sunday 18 October 2020 to be valid for the meeting. Your proxy may be appointed in a variety of ways as described in the Notice of Annual General Meeting under 'Proxies'.

## **Proxy/Voting Form**

#### How to Vote on Items of Business

All your securities will be voted in accordance with your directions.

#### **VOTE DIRECTLY**

Voting 100% of your holding: Mark either the For, Against or Abstain box opposite each item of business. Your vote will be invalid on an item if you do not mark any box OR you mark more than one box for that item.

Voting a portion of your holding: Indicate a portion of your voting rights by inserting the number of securities you wish to vote in the For, Against or Abstain box or boxes. The sum of the votes cast must not exceed your voting entitlement.

#### APPOINTMENT OF PROXY

Voting 100% of your holding: Direct your proxy how to vote by marking one of the boxes opposite each item of business. If you do not mark a box your proxy may vote or abstain as they choose (to the extent permitted by law). If you mark more than one box on an item your vote will be invalid on that item.

Voting a portion of your holding: Indicate a portion of your voting rights by inserting the percentage or number of securities you wish to vote in the For, Against or Abstain box or boxes. The sum of the votes cast must not exceed your voting entitlement or 100%.

Appointing a second proxy: You are entitled to appoint up to two proxies to attend the meeting and vote on a poll. If you appoint two proxies you must specify the percentage of votes or number of securities for each proxy, otherwise each proxy may exercise half of the votes. When appointing a second proxy write both names and the percentage of votes or number of securities for each in Step 1 overleaf.

A proxy need not be a securityholder of the Company.
